- Dissemination of Ecological River Restoration technical Information amongst ca. 2500 individuals
- Establishment of River Restoration
 National and Topic Centers now 14 organisations
- Annual workplan for and with all members, and largely in collaboration with Wetlands International
- Partnerships with various International Water Organisations GWP(CEE), ICPDR

- Large variety of land and water management measures
- A framework for sustainable multifunctional use of rivers
- More than just implementing EU Directives
- EU Directives are drivers for river restoration progress




River Continuity





Natural Water Retention Measures















NBS – integrating nature

Europe's rivers – 20 years on

40% + 17% heavily modified

European Environment Agency reports:

- Only 40% of surface waters in good ecological condition.
- With the main pressures:
 - Hydro-morphological
 - Diffuse pollution
 - Point source pollution 18%
 - Water abstraction 7%
- Deterioration of rivers / waters stopped....Y/N?




WFD & Fitness Check process (REFIT)

 - Position statement on the impact of Water Framework Directive on restoring rivers.

Defn. The re-establishment of natural physical processes (e.g. variation of flow and sediment movement), features (e.g. sediment sizes and river shape) and physical habitats of a river system (including submerged, bank and floodplain areas).



CEN Standard for 'River Restoration'

European Committee for Standardization

(CEN: Comité Européen de Normalisation) – 34 countries

Final draft of new CEN standard for 'River hydromorphology & modification' Proposal for 'River Restoration' from WG 25

- Encourage a consistent approach to survey, monitoring and assessment around Europe
- Contribute to work on European directives, such as the WFD and the Habitats Directive
- Encourage international collaboration in developing new methods
- Provide a framework to help countries without their own national methods to develop them
