- "Basin Organizations", entrusted by relevant public administrations with integrated water resources management at the level of important river basins, either national, federal or transboundary, as well as the cooperation structures they have developed among them.

 - in applying integrated and sustainable water resources management:
 - organized at the level of river basins,
 - associating administrations and local authorities, as well as users,
 - having specific budgetary resources at their disposal, obtained by applying the "user-polluter-pays" principle.
- bi and multilateral co-operation agencies supporting activities related to integrated and sustainable water resources management at the level of river basins.



 - BUFFER GRASS AND FORESTED STRIPS ALONG WATERCOURSES,
 - FLOOD MANAGEMENT (USE OF FLOOD PLAINS AS A MEANS OF STORAGE)...etc.



IT IS NECESSARY TO PROMOTE A SCIENCE-POLICY INTERFACE BETWEEN RESEARCHERS AND WATER MANAGERS



DEVELOPING NEW KNOWLEDGE AND NEW KNOW-HOW IN THE FIELD OF RIVER HYDRO-MORPHOLOGY, RESTORATION AND PROTECTION OF AQUATIC ECOSYSTEMS IS A KEY ISSUE FOR THE FUTURE

THESE PROJECTS ARE OFTEN LIMITED BY LACK OF KNOWLEDGE, PRACTICAL EXAMPLES AND OF INFORMATION OF THE PLANNERS AND MANAGERS.

THERE IS A STRONG NEED FOR KNOWLEDGE AND KNOW-HOW IN RIVER HYDRO-MORPHOLOGY, RESTORATION AND PROTECTION OF AQUATIC ECOSYSTEMS, TO ALLOW DEVELOPING SUCH PROJECTS.

MUCH CAN BE LEARNED FROM COUNTRIES THAT HAVE EXPERIENCE IN THIS FIELD.

IT IS THEREFORE VITAL TO DEVELOP AND SHARE INFORMATION ON BEST PRACTICES IN RIVER HYDRO-MORPHOLOGY AND RESTORATION OF RIVERS AND WETLAND ECOSYSTEMS.
